#### Rationale

St John's Church of England Primary School has an obligation under section 78 of the Education Act (2002) which requires all schools, as part of a broad and balanced curriculum, to promote the Spiritual, Moral, Social and Cultural (SMSC) development of students at the school.

In June 2014, the Secretary of State for Education announced that schools would be required to actively promote British Values from September 2014.

In 2011 the government set out its definition of British Values as:

- Democracy
- The rule of law
- Individual liberty
- Mutual respect
- Tolerance of those with different faiths and beliefs

#### Aims and Objectives

This is achieved through enhancing pupils' understanding of their place in a culturally diverse society and by giving them opportunities to experience such diversity.</li> <li>Tolerance of different faiths and beliefs is promoted through the LDBS Syllabus for Religious Education. The RE syllabus focuses on learning 'about' and 'from' different religions. Children learn about different religions, their beliefs, places of worship and festivals. Members of different faiths, religions and those who speak languages other than English are encouraged to share their knowledge to enhance learning within the classroom and school.</li> <li>Opportunities for children to visit places of worship and visitors to come into our school are planned for. Through this, our pupils gain and enhance their understanding of their place in a culturally diverse society.
